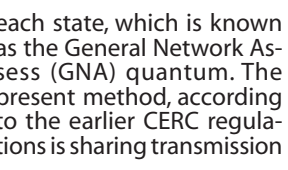

TN power utility opposes proposed changes in calculating transmission charges

Chennai, July 21 (IANS) The Tamil Nadu Generation and Distribution Company (Tangedco), which is the state's power utility company' has opposed the proposed changes in calculating transmission charges when power is imported to the state through inter-state transmission grids.

It is to be noted that the Central Electricity Regulatory Commission (CERC) has recently brought certain regulations in calculating the transmission charges while power is being imported through inter-transmission grids.

According to the new regulations brought in by the CERC, the transmission charges will be calculated based on the draws of



each state, which is known as the General Network Assess (GNA) quantum. The present method, according to the earlier CERC regulations is sharing transmission

Central Electricity Authority (CEA), Tangedco has stated that the methodology of computation of GNA was not acceptable. The Tamil Nadu power utility also informed that this was against the present and existing contracts. Tangedco also opposed the removal of a clause in the Draft Central Electricity Regulatory Commission that provides exemption of power drawal from the generation stations connected with the Interstate transmission grid. Tangedco said that removal of the clause would impact the transmission charges and lead to the loss for Tamil Nadu. The drawal quantum of Tamil Nadu as per the transmission billing charges for July 2022 was 8187 MW.

China slaps \$1.18 bn fine on ride-hailing major Didi Global over national security

Hong Kong, July 21 (IANS) The Cyberspace Administration of China (CAC) on Thursday fined ride-hailing company Didi Global \$1.18 billion after a year-long probe that found the company breaking data security and personal information protection laws.

Senior executives Will Cheng Wei and Jean Liu Qing were each fined 1 million yuan, the regulator said, reports South China Morning Post.

The CAC said in its statement that Didi committed 16 offences involving the il-

legal collection of data from drivers and passengers.

"They include the illegal processing of 64.7 billion personal information entries over the span of seven years since June 2015," the report said.

The Chinese authorities initiated a cybersecurity probe into Didi, after it launched a \$4.4 billion IPO in New York in June last year.

"The investigation shook investor confidence in Chinese technology stocks. Since then, few Chinese companies have chosen to list in the US," the re-

port mentioned. "Didi has failed to perform its duty to maintain cyberspace security, data security, and personal information protection a bringing serious risks to national cyberspace security and data security," the regulator said. "Moreover, even with clear orders from regulatory authorities to correct the issues, Didi failed to carry out comprehensive and in-depth rectifications. The nature of the offences was egregious," it added. After cracking down on big internet companies like Alibaba and Tencent, China is now mulling regulations that seek to classify online data based on importance like national security. Didi was found to have illegally collected nearly 12 million pieces of photo information from users' phones, 107 million entries of facial recognition data, 53.5 million entries of age data, 16.3 million entries of occupation data, and 1.4 million entries of data about family relations. With crackdowns on Internet companies, China has also tightened mobile app development rules with stricter requirements for content and data protection.

Now anyone can migrate WhatsApp chats from Android to iOS, vice versa

San Francisco, July 21 (IANS) Meta-owned messaging platform WhatsApp has announced that it now allows users to transfer their chat history from Android to iOS and vice versa for all users.

On the micro-blogging platform, the company also shared a link that tells how to migrate WhatsApp data from Android to iPhone.

"A new way to keep the chats that mean the most. Today, you will have the ability to transfer your entire chat history from Android to iOS and vice versa. Now you have the freedom to switch to and from your preferred devices," the company wrote on Twitter.

WhatsApp mentioned that if users are moving from an Android phone to an iPhone, they can transfer their account information,

profile photo, individual chats, group chats, chat history, media, and settings.

However, users cannot transfer their chat history or

display name. Recently, the company said that iPhone users can migrate their WhatsApp data using the 'Move to iOS' app.

Business Brief

Ministers to go abroad to prepare ground for UP global summit

Lucknow, July 21 (IANS) Foreign jaunts have been a strict taboo for ministers in the Yogi Adityanath government till now.

But with the global investors' summit being held in January next year, the chief minister has decided to send 'Group of Ministers' (GoM) on foreign tours. These tours by ministers would be aimed at globally marketing Uttar Pradesh as an investment hub, ahead of the proposed Global Investors' Summit (GIS) in January 2023.

According to a government spokesman, "Between September and November, roadshows are likely to be held in the UK, the US, Canada, UAE, Sweden, Singapore, The Netherlands, Israel, Japan, France, Germany, South Korea, Mauritius, Russia and Australia." As part of the marketing strategy, the ministers would be holding roadshows, hold talks about the "investment-friendly environment" and invite global industry leaders for investment.

The GoM will also meet people of UP origin residing abroad and talk about the state's transformation. As of now, a cabinet minister's team might have two ministers of state with independent charge and a minister of state. Singapore has reportedly proposed to be the first country partner for the GIS. The Netherlands, Japan, Slovakia, Finland, Czech Republic, Mauritius, Thailand, Nepal and Belgium have been the state's country partners in the Lucknow's 2018 investors' summit.
