The liability of Airtel under the DoT demand notices is clearly laid down in the clauses of the scheme of arrangement.

As per Clauses 5.1, "All liabilities of Tata-Tele relating to demerged undertaking shall stand transferred and vest into Airtel to become liability of Airtel".

Clause 5.3 states that all liabilities and obligations of Tata-Tele relating to demerged undertaking shall be met, discharged & satisfied by Airtel.

Clause 5 reads, "All legal proceedings against Tata-Tele relating to the demerged undertaking e to be continued and enforced against Airtel in the same manner and extent it would have been against Tata-Tele".

To invoke the last resort of lifting the corporate veil and acquire promoter assets, the shareholding structure would come into play.

Vistara to induct B787-9 Dreamliner, A321 for long-haul flights

New Delhi, Tata-Singapore Airlines (SIA) joint venture carrier Vistara will induct two Boeing 787-9 Dreamliner and one A321neo this fiscal to launch medium and long-haul international flights. Seeking to scale up its overseas flights, the airline has already entered into strategic codeshare partnerships with global carriers like United Airlines and Japan Airlines. Vistara CEO Leslie Thng told IANS that the airline has widened the scope of existing agreement with Singapore Airlines and SilkAir to provide an ex-

tended international network to its customers. Expanding aggressively its operations, the airline is expected to almost double its fleet size by the end of the current fiscal ending March 31, 2020. Its fast expansion has allowed the full-service carrier to increase its weekly flight count to 1,400, up 70 per cent compared to 800 flights a week in March this year."Our fleet has increased by over 50 per cent so far and the size will have almost doubled by the end of this financial year. All of it reflects our commitment to growing Vistara in scale and size,

which is our top priority," Thng said. The airline has so far received three of the 50 Airbus A320neo family aircraft it ordered last year. "In the last seven months, we have added 13 aircraft to our fleet, including 9 Boeing 737-800NG and four A320neo. We have already received three of the 50 aircraft from the Airbus A320neo family that we had ordered last year, and six more A320neo are expected in the next two months,"Thng said.While he remains bullish on Indian aviation, Thng expressed concern over airport infrastructure constraints.

'Downturn 'self-inflicted', most severe in 20 years'

The current slowdown has been the most severe one in the last 20 years said a Centrum brokerage firm report, adding that its impact has been "unprecedented" on both rural and urban demand. It forecast growth rebound only by first or second quarter of

While all the past three downturns have been either due to exposure of heightened external vulnerabilities or natural calamities, Centrum claimed, the ongoing slowdown seems to be "self inflicted".

The report said that the slowdown has been on account "of 3 successive shocks in 3 years in the form of demonétisation, rolling out of GST in not so phased manner coupled with the blowout of NBFC crisis".

Sensex hits life-time high, crosses

Mumbai,

The Indian equity markets opened on a firm note on Monday as the benchmark Sensex touched a fresh all time high of 40,434.83 during the early trade.

Sensex jumped nearly 250 point, gaining for the seventh straight session over strong inflow of foreign funds and better than expected earnings post the corporate tax cut. Global markets have also gained after both US and China indicated an early resolution.

At 9.27 a.m., the Sensex was up 216.40 points or 0.54 per cent at 40,381.43 before it touched the intra-day high of 40,434.83. Nifty was also trading higher by 81.70 points at 11,972.30, slightly lower from its 52 week high of 12,103.05.

Petrol prices fall for 4th consecutive day, diesel prices down

New Delhi,

Petrol prices dropped for the fourth consecutive day across the four metros on Monday, while diesel prices also registered a decline after a two-day break.

Petrol prices in Delhi, Mumbai and Chennai were reduced by nine paise per litre, while in Kolkata there was a reduction of eight paise per litre. Diesel prices, on the other hand, were reduced by five paise in Delhi, three paise in Kolkata and Mumbai, and two paise per litre in Chennai. According to the Indian Oil website, petrol prices in Delhi, Kolkata, Mumbai and Chennai have come down to Rs 72.65, Rs 75.37, Rs 78.33 and Rs 75 per litre respectively. Diesel prices in the four metros have come down to Rs 65.75, Rs 68.16, Rs 68.96 and Rs 69.50 per litres respectively.

OnePlus 6, 6T receives Android 10

OnePlus has started to upgrade the OnePlus 6 and 6T models to Android 10 as it starts the rollout of OxygenOS 10.0 via stable channel.

The Android 10 based OxygenOS 10 will be rolled out to OnePlus 6 and OnePlus 6T owners in a staged manner. The over-the-air (OTA) will be received by a limited number of users initially and later have a broader rollout in a few days after making sure that there are critical bugs.

"We are very excited to announce that we are ready to roll out OxygenOS version 10.0 based on Android 10 for the OnePlus 6 and OnePlus 6T," OnePlus Global Products Operations Manager, Manu J, wrote in OnePlus forum recently. The update is around 1.8GB in size. It brings in new UI and features to the OnePlus 6 series, like new navigation gestures, customisation options and enhanced privacy controls. The update also adds the ability to block spam messages by keywords. Additionally, it also comes with Game Space and Contextual Display.

TikTok owner ByteDance unveils its first smartphone

Chinese conglomerate ByteDance that owns popular short video-sharing app TikTok has finally unveiled its rumoured smartphone named Nut Pro 3 under the Smartisan brand in China, the media has reported. The device is up on sale in China for 2,899 yuan or \$412. The device, also known as Jianguo Pro 3, was developed in tandem with smartphone makers, Smartisan, and retains the same name as Smartisan's current line of devices. As we learned earlier this year, ByteDance acquired a bunch of Smartisan patents and talent. ByteDance then helped make the Jianguo Pro 3 and packed it with branded features. Apparently, it didn't decide to change the naming scheme, Engadget reported on Friday quoting Abacus News. The new device lets users access Douyin — the Chinese version of TikTok — just by swiping up on the lock screen. Meanwhile, the Nut Pro 3 smartphone runs Qualcomm's latest Snapdragon 855+ chipset, and has four rear sensors, including a 48MP camera and is powered by a 4,000mAh battery. The smartphone has up to 12GB RAM and 256GB storage.

IndiGo server collapses, long queues at airports

New Delhi,

Passengers flying IndiGo faced long queues across airports on Monday morning after the airline's server collapsed. "Our systems have been down across the network since morning. As a result, we are expecting our operations to be impacted across the airports. All efforts are being made to resolve the issue at the earliest," the airline said in a statement.

The largest carrier by fleet size and market share, IndiGo said it was proactively informing passengers about the situation.

The airline offers close to 1,500 daily flights and connects 60 domestic destinations and 23 international destinations. It has a fleet of around 245 aircraft. Carrying 55.5 lakh passengers in September 2019, it almost flew every second air passenger in the domestic market. However, the airline's troubles have been mounting over the last few days. The aviation regulator Directorate General of Civil Aviation (DGCA) last week asked IndiGo to replace all its faulty engines powering the planes in the wake of frequent glitches reported in its Pratt & Whitney engines. Failing to comply with the DGCA order, the low-cost carrier faces the risk of its aircraft being grounded.
